# Sexual Assault Kit Barcode

- Each kit has a barcode
- Each barcode has the following scheme....
  - IN-yyXXXXXXX
    - Where yy is the 2-digit year
    - And the X's represent a unique, incrementing value for each kit
- When the kit is registered into the system, a 4-digit pin number is generated and associated to the kit.

- After Kit information and demographic information entered
  - A PIN # will be generated
  - Pin # to be provided to patient for tracking purposes
    - Recommend registering kit once consent for services obtained
    - Write Pin # on top right of Sex Crimes Application where indicated.
      - Give to Patient at time of Discharge with discharge paper work
  - WRITE PIN # on SA Kit above barcode Request per crime lab
  - Do NOT document pt pin # in patient chart/record



# Reminders:

- Make sure you request new/updated versions of Sex Crimes Victims Applications: Indiana Criminal Justice Institute: 317-232-0157
- Identify 2 Administrators to add/remove staff for tracking purposes
  - Be thinking of charge staff that are also involved in transferring chain of custody over to law enforcement- they will need access
  - Develop a process for your sites regarding this to prevent delays
